

Meeting: Antrim Conservation Commission, January 30, 2019 at 530 pm at the Town Hall.

1. Draft December 2018 meeting notes were reviewed amended and accepted.
2. **Trails:**
 - a. **Campbell Pond** – ACC notified by Monadnock Conservancy (MC) on Dec 6, 2018 that someone has been using Campbell Pond as a campsite and ATVs have been riding on the property. This was observed by MC during the annual stewardship site review. Both uses are prohibited. Peter will investigate further and get back to MC along with NH Fish & Game as advocated by MC.
 - b. **Meadow Marsh Trail** – Peter contacted by Brian Beihl that someone rode ATVs on the trail and tore parts up. This too is prohibited on Town Conservation land. Peter will contact NH Fish & Game regarding enforcement and possible additional signage.
 - c. **Lily Pond Trail** – A spring work day is to be scheduled...
 - d. **Hurlin Property** has some substantial trees that need cutting. Schedule in winter 2019
 - e. Peter went to the January Water & Sewer Commission monthly meeting and notified the W&S commission that the Antrim Conservation Commission was approached by the Bennington Conservation Commission regarding the establishment of a trail on Town of Antrim land (Map 17, Lot 25 approximate 25.4 acres) near public water supply (well field). The W&S Commission requested that all work (conceptual & otherwise) be halted until the new Town water supply well is finalized and all work completed. This will be revisited at a future date.
3. **Planning Board:** Janet McEwen Chairperson of the Antrim Planning Board came to the meeting to discuss the pending rewrite of the Master Plan. She indicated she would like to have a mission statement from the commission and an implementation section including sections on trails, conservation lands and natural resources of the town. She provided copies of several examples of past Master Plans and copies of other towns/cities. We will revisit and meet in April/May to report progress.
