5. **Emerald Ash Borer** discussed. Updates: New sites found in Salem and Weare... Hillsborough County has been placed in Federal quarantine. More info may be found at [www.NHBUGS.org](http://www.NHBUGS.org) Emerald Ash Borer (EAB) is a non-native insect, EAB lacks predators to keep it in check. Infested trees die within 3 to 5 years. EAB only attacks ash trees, and is responsible for the death of millions of ash trees in the midwest. Help protect New Hampshire's ash trees. A quarantine of all hardwood firewood, ash wood-products and all ash nursery stock is in effect for Merrimack County.
6. There is a great need to work on the Lily Pond & Meadow Marsh Trails..To be scheduled...
