4. Trails:

- a. **Campbell Pond** In the Fall, we marked a # of Japanese Barberry bushes for removal. On April 11 the commission and friends (7) met and pulled more than 20 small and medium bushes filling 6 large construction bags which were taken & disposed of at the transfer station. Also, We need someone to contact Student Conservation Association (SCA) regarding potential trail building around pond & possible loop trail up Reily Mtn. for summer/fall of 2021. - b. **Meadow Marsh Trail** Peter hiked Meadow Marsh Trail. On April 18 we had 6 volunteers pickup and clip branches along the trail and chain saw several trees that came down during recent wind storms.
- c. **Lily Pond Trail** Trail map has been finalized and uploaded on <u>www.trailfinder.info</u> we can set a date for a hike to the ledges if you would like: **Date: mid May 16 time tbd**.
- d. **Hurlin Property** Linda contacted Caleb Platt about brush hogging and he said he would be glad to do it. Jeremy and Griffin have initiated the cleanup of brush and tree branches along the RoW driveway. Mr. Levesque has removed the maple line across the Row as promised. Jeremy has taken the soil sample for pH and fertility analyses. We are awaiting the analyses results.
- e. **Meetinghouse Hill Trail** to the Meetinghouse Hill Cemetery needs to be re-established. Peter has contacted Andrew Robblee (before the pandemic) re: new trail easement agreement. Peter will revisit after pandemic is resolved.
