

Town of Antrim Select Board Meeting Minutes April 10, 2023 6:00 PM

Mr. Ott opened the meeting at 6 pm.

Ms. Hanson moved to approve the minutes of March 27th as amended. Mr. Ott seconded. Mr. Edwards abstained. Vote passed.

Ms. Hanson moved to approve the committee assignments. Mr. Edwards seconded. Vote passed.

Water and Sewer, SAC, Planning Board – Mr. Edwards Scholarship Committee, Community Board, CIP – Ms. Hanson Park & Rec, Stewardship Building Plan Committee – Mr. Ott Ms. Gorga and Ms. Lunetta from Park & Recreation asked for the Select Board's support to apply for a municipal boat launch grant for Gregg Lake. The Select Board gave their approval. Select Board Chairman – Mr. Ott Select Board Vice-Chair – Ms. Hanson

The Select Board agreed that insulation was needed in the existing highway garage but questioned whether there was enough money in the warrant article to do this. There were also questions about a fire alarm being installed.

A contract proposal from 2022 was reviewed from Quantum Consulting Engineers for Slaughter Barn Brook. An updated quote was requested.

Mr. Edwards moved to accept the first paragraph of the petition to layout Mullhall Farm Road and Commercial Drive. The petition was submitted by residents of those roads. Ms. Hanson seconded. Vote passed. A public hearing will be scheduled. Ms. Hanson said the scope of work has been established by Peter Pitsus of Underwood Engineers. The Select Board agreed to a site walk to look at things that were not visible due to snow at the time the engineer viewed the roads.

Mr. Edwards attended the water and sewer meeting.

Mr. Ott attended Park & Recreation

MS-232 was signed by the Select Board

The 3M subpoena was stayed. State of NH vs 3M company.

There was a complaint regarding the crosswalks on Main Street. The Planning Board is working with Southwest Regional Planning on a traffic study.

TransAlta submitted their annual report which is available at town hall.

Other business

Mr. John Robertson said that a meeting with Francestown and Bennington regarding the Tri-Town pit is long overdue.
