 - Public hearing pursuant to RSA 675:3 and 675:7, the Antrim Planning Board will hold a Public Hearing at its regular meeting beginning at 7:00 P.M. on Thursday, January 5, 2023 at the Antrim Town Hall on the following proposed amendments to the Zoning Ordinance and the Subdivision and Site Plan Review Regulations:
 - (1) To amend Article XI-A Shoreland Protection District to:
 - a. clarify that the setback from the shoreline remains at one hundred feet for primary structures, with exceptions subject to specific criteria; and
 - b. add provisions for a Stormwater Management Plan that is required for any proposal to locate a primary or accessory structure closer than one hundred feet to the shoreline.
 - (2) To amend the Subdivision and Site Plan Review Regulations to:
 - a. revise all language dealing with timing of Planning Board actions on applications to be consistent with recent changes in state law.
 - b. amend Section VII Driveway Permits by adding specifications that better guide the Road Agent in the issuance of permits; and
 - c. add a new paragraph N. Fire Protection, which requires all subdivisions to address adequate water supply for fire protection and includes options for meeting this need.

- **Discussion** of probable future projects.

- **Possible discussion** of Planning Board budget, depending on the Board of Selectmen's enactment of a Town budget.
